- Consolidated sales increased by 2 % to DM 289.8 million (EUR 148.2 million)
- Result up by 7 % to DM 14.3 million (EUR 7.3 million)

Augsburg, 30th October 2001. After nine months of the 2001 business year BÖWE SYSTEC AG (Security No. 523 970), Augsburg, is also continuing the growth trend of previous years. Europe's leading supplier of high performance inserting systems has reported sales and result for the first nine months of 2001 up once again over the previous year.

Consolidated sales in the first three quarters of the current business year at DM 289.8 million (EUR 148.2 million) showed a DM 5.9 million (EUR 3.0 million) rise compared with the previous 9-month record. The BÖWE SYSTEC Group increased the result at a disproportionately higher rate than the growth in sales.
